TECHNOLOGY HAS ADVANCED TO SUCH A LEVEL THAT PEOPLE WITH SEVERE MOBILITY LIMITING ISSUES ARE ABLE TO ACCESS RESOURCES FAR BEYOND WHAT A MONKEY CAN PROVIDE. NOW THE ORGANIZATION, STAYING TRUE TO ITS MISSION OF PROVIDING SERVICES TO THOSE LIVING WITH PHYSICAL DISABILITIES, PRIMARILY SPINAL CORD INJURIES AND MULTIPLE SCLEROSIS, AS WELL AS OTHER DEBILITATING INJURIES AND ILLNESSES, IS TRANSFORMING FROM A SERVICE ANIMAL MODEL TO USING INNOVATIVE TECHNOLOGIES - A SEISMIC AND EXCITING TRANSFORMATION.

TO ASSIST THE PROCESS AND CONTINUE TO TRANSITION THE ORGANIZATION IS:

- ENGAGING IN RESEARCH OF TECHNOLOGY THAT IS AVAILABLE IN THE AREAS OF ROBOTICS AND VIRTUAL REALITY.
- LOOKING FOR WAYS TO INFLUENCE THE DEVELOPMENT OF NEW TECHNOLOGIES THAT ARE IMPORTANT TO THOSE LIVING WITH PHYSICAL DISABILITIES.
- BRINGING ON ADVISORY COMMITTEES WITH EXPERTS IN THE FIELD TO ADVISE US ON TECHNOLOGIES THAT ARE AVAILABLE FOR THOSE LIVING WITH PHYSICAL DISABILITIES AND/OR MAY BE LOOKING TO INVENT TECHNOLOGIES FOR THOSE LIVING WITH PHYSICAL DISABILITIES.
- RELYING ON ITS INSTITUTIONAL KNOWLEDGE OF HOW THE ORGANIZATION HAS TRAINED THE MONKEYS AND WHAT THEIR RECIPIENTS NEEDS AS THEY TRANSITION TO A NEW PHASE.
